#### **BEHAVIORAL HEALTH SERVICES**

Behavioral health services are aimed at diagnosing and successfully treating adults, children, and adolescents with mental illness and emotional disturbances. The ultimate goal is to provide needed services to assist individuals as they recover from their illness so that they can function at their highest possible level within their community.

Outpatient behavioral health services include:

## ASPIRE CHILD & ADOLESCENT SERVICES AND ASPIRE CLUBHOUSE

Aspire BHDD Services provides behavioral health services for children, adolescents, and young adults who may be experiencing emotional, mental, and/or behavioral problems. Outpatient services are provided for the youth and their families.

The goal of the program is to reduce out-of-home placements and hospital admissions, enabling the youth to remain in their homes and communities with the proper supports to meet their needs.

The Aspire Clubhouse provides prevention and intervention services for child and adolescents at risk for out-of-home placement and Department of Juvenile Justice involvement as well as those who may be experiencing difficulties at school.

#### **CRISIS INTERVENTION SERVICES**

Aspire BHDD Services operates the Behavioral Health Crisis Center located on 11<sup>th</sup> Avenue in Albany. The center includes a 24/7 walk-in Crisis Navigation Unit, Comfort Zone 24-hour Observation Unit, and Crisis Stabilization Unit (CSU). The CSU is designed to serve as a community-based alternative to hospitalization, offering residential psychiatric stabilization and detoxification services on a short term basis.

#### ADDICTIVE DISEASE SERVICES

The primary focus of addiction treatment is the discontinuation of addictive substances by the individual. Chemical dependency is a primary, progressive, chronic, and potentially fatal disease which is treatable. It is an illness that affects the physical, mental, and spiritual areas of the addicted person's family, social, and occupational well-being. Recovery from addiction is an ongoing process that includes abstinence and the treatment of the whole person.

Addictive Disease services include:

### DEVELOPMENTAL DISABILITY SERVICES

Aspire BHDD Services' developmental disability services are person-centered and are planned according to the expressed needs and wants of the individual served. Services keep individuals actively involved in planning their lives and participating as members of the community at home and at work. For those who cannot remain in their own home, residential services are available.

Aspire BHDD Services currently operates three centers serving individuals with developmental disabilities for the purpose of providing **c**ommunity access to help participants acquire, retain or improve self-help, socialization and adaptive skills required for active participation and independent functioning outside the home.

Developmental Disability services include:

- Community Access participation in the community through group or individual activities
- Prevocational Services development of job skills
- Employment in the community
- Support to live in the home of a participant's family member
- Support to live in a home the participant rents/owns
- Support to live in a host home chosen by participant
- Nursing services
